NOTIFICATION LETTER REGARDING ANNUAL REPORT

Learn Ex-Gratia (Pty) Ltd was registered as a private college under the *Continuing Education and Training Act, 2006* (the Act), and the *Regulations for the Registration of Private FET Colleges, 2007* (the Regulations) following the *Joint Communiqué 1 of 2016: The Registration and Accreditation of Private Education and Training Providers Offering Qualification and Part-Qualifications on the Occupational Qualifications Sub-Framework*.

In terms of Regulation 18 of the Regulations *Learn Ex-Gratia (Pty) Ltd* is supposed to submit an annual report together with certain documentary evidence to maintain its registration with the Department. As a result of Gazette No. 43007 of 07 February 2020 (attached for easy reference), *Learn Ex-Gratia (Pty) Ltd* is no longer required to submit an annual report. However, *Learn Ex-Gratia (Pty) Ltd's* registration remain active and valid with the Department until its expiry date indicated in the letter of registration. Upon its expiry of its date of registration, *Learn Ex-Gratia (Pty) Ltd's* name will be removed from the register of private colleges and the certificate of registration in its possession should then be returned to the Department.

Should *Learn Ex-Gratia (Pty) Ltd* wish to amend its registration to extend scope of qualifications, change its legal name and to add or discontinue a site of delivery, it must do so with the Quality Council for Trades and Occupations (QCTO). However if it wishes to offer General and Further Education and Training Qualifications (Umalusi), *Learn Ex-Gratia (Pty) Ltd* must lodge an application for amendment of registration with the Department.
